Job van Boven obtained his PharmD and PhD at the University of Groningen (The Netherlands), where his thesis focused on the cost-effectiveness of adherence enhancing interventions in patients with Chronic Obstructive Pulmonary Disease (COPD).

After his PhD research, he completed fellowships at the University of Colorado (USA), Monash University (Australia) and the Hospital Universitario Son Espases (Spain).

He is currently Assistant Professor of Cost-effective Respiratory Drug Utilization at the University Medical Center Groningen (The Netherlands) and Principal Investigator at the Groningen Research Institute for Asthma and COPD (GRIAC).

Professional Experiences

Dr van Boven is the founding director of the Medication Adherence Expertise Center Of the northern Netherlands (MAECON) and Chair of the European Network to Advance Best Practices & Technology on Medication Adherence (ENABLE) COST Action, funded by the European Commission.

Dr van Boven is (co)author of >100 scientific peer-reviewed publications, has an H-index of 30 (Google Scholar), is current supervisor of 8 PhD students and received several research prices & grants (including two EU grants, totalling>€3 million).
